I assume full responsibility for bodily injury, death or property damage while at the **S Bar J Ranch or S Bar J Ranch Clinics or Events** held elsewhere.

I agree to indemnify and to save and hold harmless the released parties from loss, liability, damage, or cost that they may incur due to my presence at **S Bar J Ranch or S Bar J Clinics or Events** held elsewhere or my participation of equestrian events the "Released Parties" sponsor.

I AM AWARE THAT THESE ACTIVITIES INVOLVING HORSES CAN BE HAZARDOUS AND I AM VOLUNTARILY PARTICIPATING IN THESE ACTIVITIES WITH THE FULL KNOWLEDGE OF THE DANGER INVOLVED, AND HEREBY AGREE TO ACCEPT ANY AND ALL RISKS OF PERSONAL INJURY OR DEATH OR PROPERTY DAMAGE, AND VERIFY THIS STATEMENT BY PLACING MY INITIALS HERE X.
